## **How QuIET stores personal information**

If you have donated to BHS or RFS, the necessary data is securely stored by the QuIET secretary. If you have subscribed to the Friends of Brummana High School (FBHS), your name and email address is securely stored by the convener of FBHS.

We delete your name and contact details 3 years after you provide it unless you indicate continued interest. Any records we need to keep after that period are anonymised.

## Your data protection rights.

Under data protection law, you have right to:

- ask us for copies of your personal information.
- ask us to rectify personal information you think is inaccurate, and to complete information you think is incomplete.
- ask us to erase your personal information in certain circumstances.
- ask us to restrict the processing of your personal information in certain circumstances.
- object to the processing of your personal information in certain circumstances.
- ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
